DPW Superintendent - J. Bechy

- Met with Oneida County Soil and Water and Trouts Unlimited to start permit and paperwork necessary to start work on the two washout areas in Big Creek. Trouts Unlimited will be working on four areas of Big Creek from Stewarts going down Rte. 315.
- Babbott Park playground equipment has arrived. The DPW crew have been working on constructing equipment and preparing the park grounds. The playground updates should be completed this coming spring.
- Received \$50,000 SAMS grant for the work done on Big Creek near the Village well fields.
- Sent out a Request for Bids for a fuel contract. Received two bids: one from Broedel Fuel and one from Buell Fuell. Broedel bid \$3.40/gal for Summer fuel and \$3.75/gal for Winter Blend fuel. Buell Fuel bid \$3.19/gal for Summer fuel and \$3.54/gal for Winter Blend fuel. DPW Bechy would like to accept the bid from Buell Fuel.
