1 Repeal of Inconsistent Ordinances

 All resolutions, ordinances or parts of ordinances or local laws related to the regulation of parking within the Village of Waterville established prior to ______ are hereby repealed. See Appendix A for listing of repealed ordinances and local laws per this resolution.

2 Effective Date

1. This local law shall take effect immediately upon its being filed in the office of the Secretary of State.

3 Assumptions

- 1. Parking is assumed to be allowed on the sides of all streets and in any public parking areas unless specifically detailed in section 7.
- 2. All streets within the jurisdiction of the Village of Waterville shall be considered bidirectional unless specifically detailed in section 9.1.
- 3. All turns shall be assumed legal unless specifically detailed in section 9.2.
- 4. New York State parking and traffic regulations supersede the authority of this code and are assumed to be applicable throughout the jurisdiction of the Village.

4 Definitions

The words "crosswalk", "sidewalk", "vehicle", "park", "parking", "parked", "standing", "stop", "violation", as used herein shall have the meaning as defined in the Vehicle and Traffic Law of the State of New York.

OVERSIZED VEHICLE: Every vehicle having an overall length of more than twenty-one (21) feet or an overall width of more than eight (8) or an overall height (exclusive of aerials or similar accessories) of more than eight (8) feet. All such widths are inclusive of loads and attachments.

5 Enforcement

A violation of any section of this code shall, upon conviction, bring a fine of \$50.00 unless offense took place within a school zone, where fines may be increased. Speed and traffic violations may be subject to increased fines based on New York State Vehicle and Traffic Law, and at the discretion of the Municipal Court. Each violation of any section of this code shall be considered an independent occurrence that will justify its own citation for appearance in court, and unique fine if a conviction is reached.

6 Traffic Speed

6.1 Village Streets

1. No person shall operate a motor vehicle or motorcycle upon any road, street, avenue, alley or public place within the Village limits at a rate of speed greater than (30) thirty miles per hour unless specified in this section.

- 6.1.2 Huntington Place
 - 1. Speed limit of (15) fifteen miles per hour between intersection of Tower Street and termination of roadway.

6.2 School Zones

- 1. No person shall operate a motor vehicle or motorcycle in a designated school zone at a rate of speed greater than (20) twenty miles per hour.
- 2. School zone designations:
 - a. Bacon Street, East: approximately (300) three-hundred feet eastward of school property.
 - b. Conger Avenue: approximately (200) two-hundred feet southward of intersection with Bacon Street, East.
 - c. Bacon Street, West: approximately (200) two-hundred feet westward of intersection with Stafford Avenue.
- 6.2.1 Signage Requirements
 - 1. Every school zone must have a sign posted at its entrance designating it as a school zone, accompanied by a speed sign designating the appropriate speed.

6.3 Signage Requirements

- 1. A speed sign must be posted on every street entering the Village at the Village limit, preceded by a sign indicating a reduced speed ahead.
- 2. Signs in either direction must be posted at variation points where speed limit changes.

7 Parking Restrictions

Upon adoption, parking and standing shall be prohibited for the following criteria within the jurisdiction of the Village:

7.1 General

- 1. On Village terrace, between sidewalk and curb line/road border.
- 2. Between the hours of 0200 and 0700 from 15 November to 15 April on all roadways.
- 7.1.1 Signage Requirements
 - 1. General restrictions are posted at every entrance of the Village.

7.2 Village Parking Lots

- 1. Dead storage.
- 2. Unlicensed vehicles.
- 3. Parking duration out of compliance with lot signage.
 - 7.2.1 Firehouse Parking Lot
 - 1. No overnight parking.
 - 7.2.2 Village (Main Street) Parking Lot
 - 1. No overnight parking.

- 7.2.3 Village Hall Parking Lot
 - 1. Between the hours of 2300 and 0700 from 15 November to 15 April.
- 7.2.4 White Street Parking Lot
 - 1. No regulations.
- 7.2.5 Electric Vehicle (EV) Charging Stations
 - 1. Vehicles unequipped for electric charging shall not park within proximity of an EV charging station to a point where the charging station is inaccessible to electric cars.
 - 2. Vehicles using the EV charging station shall not park at the station longer than the amount of time required to charge their vehicle.
- 7.2.6 Signage Requirements
 - 1. Parking lots with time limits or overnight restrictions must have at least (1) one sign indicating the restrictions posted.
 - 2. Parking lots out of view of community must indicate Village bears no responsibility for vehicles parked therein.

- 7.3.1 Babbott Avenue, North
 - 1. No parking on easterly side between intersection of Bacon Street, West and intersection of Main Street, East.
- 7.3.2 Babbott Avenue, South
 - 1. No parking on easterly side between intersection of Main Street, East and intersection of White Street.
 - 2. No parking on westerly side between intersection of Main Street, East and intersection of White Street.
- 7.3.3 Bacon Street, East
 - 1. No parking on northerly side between intersection of Stafford Avenue and corporation line of the Village.
 - 2. No parking on southerly side between intersection of Stafford Avenue and intersection of Conger Avenue between the hours of 0700 and 0900 and between the hours of 1400 and 1600 when school is in session.
- 7.3.4 Bacon Street, West
 - 1. No parking on northerly side between intersection of Stafford Avenue and intersection of Berrill Avenue.
 - 2. No parking on southerly side between intersection of Stafford Avenue and a point 200 feet westward.
- 7.3.5 Barton Avenue
 - 1. No regulations.
- 7.3.6 Benedict Place
 - 1. No regulations.

- 7.3.7 Berrill Avenue
 - 1. No regulations.
- 7.3.8 Buell Avenue
 - 1. No regulations.
- 7.3.9 Conger Avenue
 - 1. No regulations.
- 7.3.10 Doolittle Avenue
 - 1. No regulations.
- 7.3.11 Elmwood Avenue, North
 - 1. No regulations.

 - 1. No regulations.
- 7.3.25 White Street
 - 1. No parking on southerly side between intersection of Main Streets, East & West and intersection of Osborne Avenue.
 - 2. No parking on northerly side from intersection of Main Streets, East & West eastward approximately (130) one-hundred thirty feet.

8 Crosswalk Designations

- 1. One crossing over Babbott Avenue, North and being an extension of the sidewalk on the north side of Main Street, East.
- 2. One crossing over Babbott Avenue, North and being an extension of the sidewalk on the southerly side of Bacon Street, West.
- 3. One crossing over Babbott Avenue, South and being an extension of the sidewalk on the northerly side of White Street.
- 4. One crossing over Babbott Avenue, South and being an extension of the sidewalk on the southerly side of Main Street, East.
- 5. One crossing over Bacon Street, East and being an extension of the sidewalk on the easterly side of Stafford Avenue.
- 6. One crossing over Bacon Street, East from the southwesterly bounds of the property of Memorial Park School to the sidewalk on the southerly side of Bacon Street, East.
- 7. One crossing over Bacon Street, West and being an extension of the sidewalk on the easterly side of Berrill Avenue.
- 8. One crossing over Bacon Street, West and being an extension of the sidewalk on the westerly side of Stafford Avenue.
- 9. One crossing over Barton Avenue and being an extension of the sidewalks on the southerly side of Main Street, East and on the southerly side of Putnam Street.
- 10. One crossing over Barton Avenue, being an extension of the sidewalk on the northerly side of White Street.
- 11. One crossing over Benedict Place and being an extension of the sidewalk on the easterly side of Elmwood Avenue, South.
- 12. One crossing over Berrill Avenue and being an extension of the sidewalk on the easterly side of Buell Avenue.
- 13. One crossing over Buell Avenue and being an extension of the sidewalks on the northerly side of Main Street, East and northerly side of Main Street, West.
- 14. One crossing over Conger Avenue and being an extension of the sidewalk on the northerly side of Putnam Street.

- 15. One crossing over Conger Avenue and being an extension of the sidewalk on the southerly side of Bacon Street, East.
- 16. One crossing over Elmwood Avenue, North and being an extension of the sidewalk on the northerly side of Putnam Street.
- 17. One crossing over Elmwood Avenue, South and being an extension of the sidewalk on the northerly side of White Street.
- 18. One crossing over Elmwood Avenue, South and being an extension of the sidewalk on the southerly side of Putnam Street.
- 19. One crossing over Madison Street and being an extension of the sidewalk on the westerly side of Park Place to the sidewalk on the northerly side of Madison Street.
- 20. One crossing over Madison Street from the sidewalk on the southerly side of Madison Street at the northeast bounds of property of 381 Madison Street to the sidewalk on the northerly side of Madison Street at the southeasterly bounds of property of 358 Madison Street.
- 21. One crossing over Madison Street from the southeasterly corner of Terry Place and Madison Street to the sidewalk on the southerly side of Madison Street.
- 22. One crossing over Main Street, East and being a southerly extension of the sidewalk on the easterly side of Babbott Avenue, North to the sidewalk in front of 202 Main Street, East.
- 23. One crossing over Main Street, East and being an extension of the sidewalks on the westerly side of Babbott Avenue, North and Babbott Avenue, South.
- 24. One crossing over Main Street, East and being an extension of the sidewalks on the westerly side of Stafford Avenue and Barton Avenue.
- 25. One crossing over Main Street, East from the westerly bounds of the property of 110 Main Street, East to the sidewalk on the northerly side of Main Street, East.
- 26. One crossing over Main Street, West at the intersection of Buell Ave to the sidewalk on the southerly side of Main Street, West.
- 27. One crossing over Main Street, West northerly from the sidewalk at 129 Main Street, West to the sidewalk at 126 Main Street, West.
- 28. One crossing over Osborne Avenue and being an extension of the sidewalk on the southerly side of White Street.
- 29. One crossing over Putnam Street and being an extension of the sidewalks on the easterly side of Elmwood Avenue, North and easterly side of Elmwood Avenue, South.
- 30. One crossing over Putnam Street and being an extension of the sidewalks on the easterly side of Stafford Avenue and Barton Avenue.
- 31. One crossing over Sanger Avenue and being an extension of the sidewalk on the westerly side of Park Place to the sidewalk on the easterly side of Sanger Avenue.
- 32. One crossing over Sanger Avenue from the sidewalk on the northerly side of Madison Street to the sidewalk on the southerly side of Sanger Avenue.
- 33. One crossing over Stafford Avenue and being an extension of the sidewalks on the northerly side of Bacon Street, West and Bacon Street, East.
- 34. One crossing over Stafford Avenue and being an extension of the sidewalks on the southerly side of Bacon Street, West and Bacon Street, East.
- 35. One crossing over Stafford Avenue from 199 Stafford Avenue to the parking lot opposite, on the westerly side.

- 36. One crossing over Tower Street from the walkway and steps on the northwesterly bounds of the Soldiers and Sailors Monument Association Park to the sidewalk on the northerly side of Tower Street.
- 37. One crossing over White Street and being a southerly extension of the sidewalk on the easterly side of Barton Avenue to the sidewalk on the southerly side of White Street.
- 38. One crossing over White Street and being a southerly extension of the sidewalk on the west side of Babbott Avenue, South to the sidewalk on the southerly side of White Street.
- 39. One crossing over White Street and being a southerly extension of the sidewalk on the westerly side of Barton Avenue to the sidewalk on the southerly side of White Street.
- 40. One crossing over White Street and being a southerly extension of the sidewalk on the westerly side of Doolittle Avenue to the sidewalk on the southerly side of White Street.
- 41. One crossing over White Street and being an extension of the sidewalk on the easterly side of Babbott Avenue, South, to the sidewalk on the southerly side of White Street.
- 42. One crossing over White Street and being an extension of the sidewalks on the easterly side of Elmwood Avenue, South and easterly side of Osborne Avenue.
- 43. One crossing over White Street and being an extension of the sidewalks on the southerly side of Main Street, West and southerly side of Main Street, East.

1. Except when directed to proceed by a police officer, every driver of a vehicle approaching a control signal, stop sign, or yield sign shall stop at a clearly marked stop line, but if none, then shall stop before entering the crosswalk on the near side of the intersection, or in the event there is no crosswalk, at the point nearest the intersecting roadway where the driver has a view of the approaching traffic on the intersecting roadway before entering the intersection. The right to proceed shall be subject to the provisions of Section 1142 of the Vehicle and Traffic Law of the State of New York.

9.5 Signage Requirements

1. All intersections shall be marked with appropriate signs denoting street names.

- 2. All points where traffic must stop and/or yield must be marked with a standard Stop or Yield sign, or traffic control device.
- 3. All instances where traffic is restricted to one direction must be adequately marked at each intersection where vehicles may potentially turn in the prohibited direction.
- 4. All instances where specific turns are prohibited must be adequately marked at the location where the potential prohibited turn may occur. If prohibited turn is other than a U-turn, adequate signage must be posted at the preceding intersection to indicate the restriction ahead.

No person shall operate a motor vehicle or motor cycle upon any street, road, avenue, alley or public place within the Village limits at a rate of speed greater than thirty (30) miles per hour, and any person guilty of a violation of this Ordinance shall be liable to a penalty of not more than Ten (\$10.00) Dollars fine for the first offense and not more than Fifty (\$50.00) Dollars fine for each subsequent offense or, in lieu of said penalty, to imprisonment of one day for each dollar of fine imposed and unpaid.

(As amended) No person shall operate a motor vehicle or motorcycle upon any road, street, avenue, alley or public place within the Village limits at a rate of speed greater than (30) thirty miles per hour. Any person guilty of a violation of this ordinance shall be punishable by a fine of not less than (\$10.00) ten dollars nor more than fifty (\$50.00) dollars.

This ordinance shall take effect ten days after the publication of this notice on June 4, 1959.

Text:

No vehicle shall be parked or left standing in the Village Parking Lot longer than the period shown on the sign duly erected therein showing the permitted parking limits in the particular part of said parking lot where such vehicle is parked or left standing.

There shall be erected by this Village, signs showing the permitted parking periods in the various sections of the Village Parking Lot which period shall not be less than one hour and more than twenty-four hours.

There shall be no dead storage or parking of unlicensed vehicles in the parking lot.

Any persons violating a provision of this ordinance shall be punishable for the first offense by a fine of not to exceed \$10.00 and for the second or subsequent offenses within one year by a fine of not less than \$10.00 nor more than \$25.00.

All ordinances or parts of ordinances of the Village of Waterville inconsistent with the provisions of this ordinance are hereby repealed.

This ordinance shall take effect immediately.

Text:

SECTION 1.

PURPOSE. Whereas Ordinance No. 23 of the Village of Waterville, adopted October 7, 1930 and amended August 3, 1931 established street crossings for pedestrians in the Village, and whereas changes in ownership and new development in the Village now make it prudent to modify the list of street crossings, the Village Board of the Village of Waterville, adopts the following local law.

SECTION 2.

Street crossings for the use of pedestrians are hereby designated and established in the Village of Waterville, and shall be marked and indicated by lines or other markings, as follows:

1. One crossing over E. Bacon Street and being an extension of the sidewalk on the easterly side of N. Stafford Avenue.

Section 1. LEGISLATIVE INTENT: Whereas it is the established policy of the Village of Waterville to maintain the safe and orderly movement of vehicular and pedestrian traffic in and about the streets of the Village of Waterville, and whereas it is hereby found that the available lanes of traffic are narrowed and visibility diminished by the parking of oversized vehicles on residential streets of the Village, it is accordingly intended that this local law to regulate the on-street parking of oversized vehicles will benefit the aforesaid policy.

Section 2. DEFINITIONS: For the purposes of this local law, the meaning of the words and expressions set forth below shall be as follows:

LOADING: The actual movement of persons, merchandise, goods or cargo into or out of a vehicle.

OVERSIZED VEHICLE: Every vehicle having an overall length of more than twenty-one (21) feet or an overall width of more than eight (8) or an overall height (exclusive of aerials or similar accessories) of more than eight (8) feet. All such widths are inclusive of loads and attachments.

VEHICLE: Every device in, upon or by which any person or property may be transported or drawn upon a street.

PARKING or PARK: The stopping of a vehicle, whether or not attended or occupied, for any interval of time longer than necessary for loading.

STREET: The length of roadway between any two consecutive road intersections or between a road intersection and the end of a road, if there be no intervening road intersection, and the entire width of the boundary lines of every way publicly maintained when any part thereof is open to the use of the public for purposes of vehicular travel.

Section 3. RESPONSIBILITY & PRESUMPTIONS: (a) It shall be unlawful and a violation of this local law for any person to operate a vehicle in any manner prohibited, and for any person to cause, allow, permit or suffer any vehicle registered in his name or operated by him to be parked in any manner or place or for any period of time prohibited by the provision hereof. (b) House coaches, busses and tractors shall be presumed to be oversized vehicles unless the contrary be demonstrated by competent evidence.

Section 4. PROHIBITION: No oversized vehicle shall be parked upon any street in the Village of Waterville for a continuous period of more than one (1) hour.

Section 5. EXCEPTION: This local law shall not apply to parking on any street designated as a state highway and maintained by the State of New York.

Section 6. VIOLATIONS: Every person who shall violate any provision of this local law shall be guilty of an offense punishable by a fine of not more than fifty (\$50) dollars for each such offense. If a violation occurs for a continuous period of more than twenty-four (24) hours, each successive period of twenty-four hours shall be deemed a separate offense.

Section 7. EFFECTIVE DATE: This local law shall take effect immediately upon filing with the Secretary of State.

Section 2. DEFINITIONS. Park or Parking -- The stopping of a vehicle, whether or not attended or occupied, for any interval of time longer than necessary for loading. Curb Line – The street side edge of any curbing of concrete, bituminous or other substance lining a Village street or avenue, or in the absence of such curbing, the edge of the street pavement.

Section 3. PROHIBITION. It shall be unlawful and in violation of this local law for any person to park, and for any person to cause, allow, permit or suffer any vehicle registered in his name, or operated by him, to be parked between the curb line of any street in the Village and the interior sidewalk line.

Section 4. VIOLATION. Every person who shall violate any provision of this local law shall be guilty of an offense punishable by a fine of not more than \$25 for each offense.

In front of the Post Office in said village.

Easterly on north side of White Street, 32 feet from point of curb intersection of White and Main Street east, and easterly on south side of Main Street east, 32 feet from point of curb intersection with White Street as marked and indicated by lines or markings.

South side of White Street, for a distance of 41 feet easterly from driveway of W.G. Mayer, as marked or indicated by lines or markings.

South side of White Street, from a point in front of Mrs. Cora Beebe's residence, No. 124 White Street, easterly for a distance of 266 feet as marked and indicated by lines or markings.

In front of the Fire Department property north side of White Street, and for a distance of 32 feet easterly, and 32 feet westerly of such property.

Easterly side of Babbott Avenue south, entire length of street.

West side of Stafford Avenue north, in front of Central School property, as marked and indicated by lines or markings.

West side of Buell Avenue, from curb intersection with Main Street west, northerly to property of New York State Gas & Electric Co, as marked and indicated by lines or markings.

Both sides of curve at intersection of Main Street west and Sanger Avenue.

Except as herein provided, diagonal or herringbone parking is permitted on Main Street east and west, from widening of Main Street east near C & U Telephone Building, westerly to easterly line of Huntington & Tyler garage property. Within this area parking other than diagonal is prohibited.

No vehicle shall be parked or left standing without front and rear lights on any street or public place in this village, after 12 o'clock midnight.

On all streets and public places in the Village of Waterville, not mentioned or included in the foregoing provisions of this ordinance, parking parallel with the curb is permitted, provided that the vehicle is parked within six inches of the curb line.

Any person violating any provisions of the foregoing ordinance shall incur and forfeit to the Village of Waterville, a penalty in the sum of \$5.00 to be recovered in a civil action.

Further ordained and enacted, that a violation of any provisions of either of the foregoing ordinances #23 or #24 – shall constitute disorderly conduct, and the person so violating the same shall be and hereby is declared a disorderly person.

Amended August 3, 1931 as follows;

Amending that paragraph which reads: "Except as herein provided, diagonal or herring-bone parking is permitted on Main Streets east and west, from widening of Main Street east near C. & U. During the time that religious services are being held at St. Bernard's Catholic Church in the Village of Waterville, no person shall leave standing any vehicle upon Stafford Avenue within the following limits-viz.

On the west side of such street from the premises of the Waterville Central School, northerly to Bacon Street, and on the easterly side of such street from the premises of B.K. Crandall, northerly to the premises of Young.

Such original ordinance as so amended imposes a penalty of \$5.00 for each violation of the same, and prescribes that each person violating the same shall be a disorderly person, and guilty of disorderly conduct.

Amended February 1, 1943 as follows:

It is enacted and ordained, that Ordinance No. 24 of the Village of Waterville, relating to the parking of vehicles upon the public streets of such village, adopted on the 7th day of October, 1930 be and the same hereby is amended and added to as follows:

No person shall park or leave standing any vehicle, upon the north side of White Street in such village between the following limits thereon as follows, viz-

Between a point opposite the southeast corner of the National Bank of Waterville Building and a point opposite to the southeast corner of Ye Olde American Hotel Building. Any person violating the same shall be deemed a disorderly person and guilty of disorderly conduct and subject to a penalty for each violation of the sum of \$2.00.

Resolution Adopted February 17, 1947

RESOLVED:

That inasmuch as we the Board of Trustees of the Village of Waterville, N.Y., deem it to the best interests of this village, we do herewith grant unto the state Traffic Commission of the Highway Department of the State of New York the authority to change the method of the parking of automobiles on the Main Street of this village, which street is part of State Highway No. 12, from the present angle parking to parallel parking.

It is understood that the cost of such change shall be borne by the State Highway Department and the Village of Waterville, N.Y., shall not be held responsible for any damage either personal or property which might occur while this change is being made.

It is understood that suitable signs and markings covering this change shall be placed by the State Highway Department and all sidewalks indicated.

Amended November 2, 1953

"Resolved that between November 15th and April 15th of each year, no vehicle shall be parked on any village street between the hours of 2 A.M. and 7 A.M. Any person violating the same shall be deemed a disorderly person and guilty of disorderly conduct and subject to a penalty for each violation of the sum of (\$2.00) two dollars."

Amended January 3, 1955 as follows:

No person shall park or leave standing any vehicle upon the public streets of the Village of Waterville in any of the following named places or areas:

On the north side of White Street opposite Gallup's Garage from the intersection of Babbott Avenue S. to east boundary of Zayda T. Pughe property.

On the south side of White Street easterly from the driveway of Helmes (formerly W.G. Mayor) to the driveway of Clifford E. Gallup opposite intersection of White Street and Babbott Avenue S.

On west side of Buell Avenue from curb intersection with Main Street northerly to the north property line of Johnson as marked and indicated by lines and/or signs.

On the north and south sides of Bacon Street W. 30 feet west from the intersection with Stafford Avenue N.

No parking or standing at any time on the west side of Stafford Avenue N. from intersection of Main Street E. northerly to a point 150 feet north of the intersection of Bacon Street W. and Stafford Avenue N.

Such original ordinance as so amended imposes a penalty of \$5.00 for each violation of the same and prescribes that each person violating the same shall be a disorderly person, and guilty of disorderly conduct.

Amended September 2, 1958 as follows:

"No person shall park or leave standing any vehicle upon the public streets of the Village of Waterville, in any of the following named places or areas; and added to as follows: Between the hours of 8 A.M. and 6 P.M. on Tower Street from its easterly intersection with Main Street to a point 750 feet westerly thereof."

Section 1. PURPOSE: It is hereby declared to be in the best interest of public safety and welfare of the residents of the Village of Waterville to regulate traffic at intersections within the Village.

Section 2. STOP SIGNS & YIELD SIGNS:

a. Except when directed to proceed by a police officer, every driver of a vehicle approaching a stop sign shall stop at a clearly marked stop line, but if none, then shall stop before entering the crosswalk on the near side of the intersection, or in

the event there is no crosswalk, at the point nearest the intersecting roadway where the driver has a view of the approaching traffic on the intersecting roadway before entering the intersection. The right to proceed shall be subject to the provisions of Section 1142 of the Vehicle and Traffic Law of the State of New York.

b. The driver of a vehicle approaching a yield sign, if required for safety to stop, shall stop at a clearly marked line, but if none, then shall stop before entering the crosswalk on the near side of the intersection, or in the event there is no crosswalk, at the point nearest the intersecting roadway where the driver has a view of the approaching traffic on the intersecting roadway before entering the intersection. The right to proceed shall be subject to the provisions of Section 1142 of the Vehicle and Traffic Law of the State of New York.

Section 3. The fine for a violation of this Local Law shall be as minimum of \$15.00 for each offense, and a maximum of \$100.00 for each offense.

Section 4. This Local Law supplements and shall not supersede any provisions of the Vehicle and Traffic Law of the State of New York.

Section 5. This Law shall take effect immediately upon filing with the Secretary of State.

The Board of Trustees of the Village of Waterville do enact and ordain as follows:

Upon the approach of any vehicle or apparatus of the Fire Department of the Village of Waterville, N.Y., answering an alarm of fire or emergency call, and sounding a bell or siren, the driver of any vehicle, other than a vehicle of the aforesaid department or an ambulance of any health department or hospital on an emergency call, shall drive as close as possible to the right curb and stop, and shall not follow within 600 feet after said vehicle or apparatus of said fire department has passed. No vehicle, except by direction of the fire chief or officer of Fire Department shall approach or park within 600 feet of a fire at any time.

Any person who shall violate in any way the provisions of this ordinance or who shall fail or refuse to comply therewith shall be liable to a fine of not less than \$5.00 nor more than \$50.00 for each offence.
